


SCVA LETTER OF COMMITMENT – JUNIOR GIRLS

DO NOT SIGN WITHOUT READING CAREFULLY. SCVA COMMITMENT LETTER FOR CLUB SEASON 2020/2021 (“SEASON”).

DO NOT SIGN PRIOR TO SEPTEMBER 22, 2020 (FOR PLAYERS BORN BEFORE JULY 01, 2006)

OR OCTOBER 6, 2020 (FOR PLAYERS BORN ON OR AFTER JULY 01, 2006).

This requirement has been created to protect the player and parent/guardian as a member of a club.

- 1. Commitment Date and Signature** ... I understand that by signing this Letter of Commitment (“Letter”), I am committing and will be considered committed to joining the club named with this document for the entirety of the current Club Season. I understand that I am not allowed to sign this Letter prior to the dates as listed below (“Referenced Dates”):
 - For Players Born Before JULY 1, 2006 ... SEPTEMBER 21, 2020
 - For Players Born On or After September 01, 2006 ... October 06, 2020
- 2. Duration of Commitment** ... My commitment as evidenced by my signature below shall remain in full force and effect through the end of my designated team’s scheduled Season. My commitment will end when my team has no further scheduled tournament events.
- 3. Basic Penalty** ... If I compete for another club than the one listed below, I may be subject to suspension for the remainder of the season.
 - a. Early Signing Period** ... A player who signs this Letter before the referenced dates is subject to suspension for the entire season. A club representative may not ask a player to sign prior to the referenced dates.
 - b. No Pre-Date or Early Tryout Signature** ... A player may not sign this Letter before the referenced dates regardless of the date of the Tryout. A player who signs a Letter or a club that allows a player to sign prior to the referenced dates at a tryout or otherwise is subject to suspension for the entire season. Under no conditions may this Letter be pre-signed or pre-dated before the referenced dates. In turn, no deposit monies, team fees, or club fees can be collected before the referenced dates.
 - c. One Letter of Commitment Permitted per Player** ... A player who signs more than one Letter with more than one club is subject to suspension for the entirety of the Club Season.
- 4. Verbal Commitments** ... A player may commit verbally to a club prior to the above referenced commitment dates. A verbal commitment is not binding. The player may revoke their verbal commitment at any time, before signing the Letter, without penalty.
- 5. Recruiting Ban After Signing** ... I understand that all clubs are obligated to respect my signing and shall cease to recruit me upon my signing this document. I shall notify any recruiter who contacts me that I have signed.
- 6. Adherence to Season Start and Practice Rules** ... I acknowledge I have reviewed and understand the SCVA Rules and Regulations for the official start of the club season, when official practices are allowed to begin, what is considered an official practice, and what activity is allowed prior to the officially listed practice start dates of October 10, 2020 (for all teams 10-14 & Under) and September 26, 2020 (for all teams 15-18 & Under). 
PARENT INITIAL
- 7. Pertinent Signatures Required Prior to Submission to the SCVA** ... This document must be signed and dated by the Club Director before being submitted to the SCVA along with other registration documents.
- 8. Parent/Guardian Signature Required** ... My parent, or legal guardian, is required to sign this Letter of Commitment if I am less than 21 years of age at the time of signing.
- 9. Falsification of Letter of Commitment** ... If I falsify any part of this Letter of Commitment, including the date, I understand that I am subject to suspension for the entirety of the Club Season.
- 10. Nullification of Other Agreements** ... My signature on this Letter of Commitment nullifies any agreements, verbal or otherwise, which would release me from the conditions stated within this document.
- 11. Binding Agreement** ... I understand that I have signed this Letter of Commitment with the club and not with a particular individual. If the coach or any player(s) leave the team, I remain bound by the provisions of this document for the entire Duration of the current Club Season. I certify that I have read all terms and conditions in this document. I have discussed them with the club representative named within, and I fully understand, accept, and agree to be bound by them.
